MINUTES

The Murray County Commissioner held a public meeting Tuesday, January 5, 2010 at 9:00 a.m. in the hearing room of the Murray County Courthouse Annex.

Commissioner Ridley called the meeting to order and welcomed those in attendance.

By signature and execution the minutes of December, 2009 were approved.

With no additions or deletions to the agenda, Commissioner Ridley adopted the agenda as presented.

Under new business the following items were addressed and approved.

**A. Approved Murray County Land Use Development Planning
Commission Minutes Dated December 15, 2009**

Chairman Steve Anglea called the meeting to order.

David McDaniel made a motion to approve the agenda, 2nd by Darrell Smith, all in favor, none opposed, motion carried.

Darrell Smith made a motion to approve the minutes of the November meeting, David McDaniel 2nd the motion, all in favor, none opposed, motion carried.

Old Business: (A) Conditional Use request by Carl Long to have horse on his property. Glenda Rymer, Daughter of Carl Long, said they had obtained additional property to house the horses. David McDaniel made a motion to approve the request with the condition that there be 1 horse and 1 mule on the property. Darrell Smith 2nd the motion, all in favor, none opposed, motion carried.

Item 1. Re-Classification of Property from SR to RR located in land lot 52 district 10 of Murray County owned by Troy Parker and addressed on Shields Road, being approximately 1 acre. Mr. Parker was present for the meeting. Mr. Parker wants to put a double wide mobile home on the property for his son. Dick Barnes said the proposal was in order for granting and the office recommends approval. Public portion of the meeting open for comments from the audience. No one present either for or against the request. Public portion of the hearing closed for board discussion.

Mr. Parker said the home would have well water. Mr. Barnes said the Environmental Health Dept. has a minimum of 1.5 acres for lots that are supplied with well water. Steve Anglea discussed zoning the property that has the mobile homes on it RR, this consists of approximately 10 acres with 3 mobile homes already on the property and the rest of the property still be SR. This would split zoned property. David McDaniel made a motion to approve the request and split zone the property, 2nd by Darrell Smith, all in favor, none opposed, motion carried.

Darrell Smith made a motion to adjourn, 2nd by David McDaniel, all in favor, none opposed, motion carried.

G. Memorandum of Understanding: for Transportation of Murray County Development Center's clients by Murray County Transit

The memorandum of understanding is made and entered into January 1, 2010 by and between MURRAY COUNTY COMMISSIONER and the MURRAY COUNTY DEVELOPMENTAL CENTER.

Under this agreement, Murray Transit, an entity of Murray County Government, will provide transportation services to clients of the Murray County Development Center. These services will include to and from the center to the client's home. Murray Transit cannot exceed allocated trips provided by Georgia Department of Human Services. Murray Transit will maintain mandated training and insurance coverage requirements, under the guidelines provided by the Georgia Department of Transportation and the Georgia Department of Human Services. Murray Transit will not transfer rights or obligations under this agreement to another entity without the prior written approval of the Murray County Developmental Center.

Murray County Developmental Center will transport their consumers for outreach or employment, using DHR vehicles. Murray County Developmental Center will be reimbursed at the current DHR rate minus \$0.25 (current trip fee less \$0.25 per trip to offset administrative costs for Murray County Transit). The DHR Regional Transportation Office will monitor trip use and service quality under this subcontract and will coordinate billing details between the Murray County Developmental Center and Murray County Transit.

Trips will be documented, per DHS requirements, by the Murray County Developmental Center and submitted to Murray County Transit by the 4th of each month's trips. Invoices will be submitted to:

The Murray County Developmental Center will be reimbursed monthly by Murray County.

This agreement may be terminated by either party with a minimum of sixty (60) days prior notice, via certified mail, to the other party at its published mailing address.
