Commissioner Ridley called the meeting to order and welcomed those in attendance.

By signature and execution the minutes of August, 2009 were approved.

With no additions or deletions to the agenda, Commissioner Ridley adopted the agenda as presented.

Under new business the following items were addressed and approved.

- A. Approved Murray County Land Use Development Planning Commission Minutes Dated August 18, 2009.**

Chairman Steve Anglea called the meeting to order.

David McDaniel made a motion to approve the agenda, 2nd by Darrell Smith.

Edward Dunn made a motion to approve the minutes of the July meeting, David McDaniel 2nd the motion, all in favor, none opposed, motion carried.

Item 1. Re-Classification of property from SR to RR, owned by Daryl and Melissa Webb, located in land lot 276 district 27 of Murray County and addressed on Old Silver Mine Road. Ms. Webb was present for the meeting. Dick Barnes said the proposal was in order for hearing and recommends approval. Nancy Young said all notices had been sent to adjacent property owners. Public portion of the hearing open for comments from the audience. No one was present either for or against the proposal. Public portion of the hearing closed for board discussion. Edward Dunn made a motion to approve the request 2nd by Darrell Smith, all in favor, none opposed, motion carried.

Item 2. Re-Classification of property from SR to RR located in land lot 235 district 10 of Murray County owned by Raymond Stafford and addressed on Summerour Church Road. Mrs. Stafford was present for the meeting. Mr. Barnes said the proposal was in order for granting and the office recommends approval. Nancy Young said all notices had been sent to adjacent property owners. Public portion of the meeting open for comments from the audience. No one present either for or against the request. Public portion of the meeting closed for board discussion. Darrell Smith made a motion to approve the request 2nd by David McDaniel, all in favor, none opposed, motion carried.

Item 3. Re-Classification of property from RR to AG in land lot 292 district 9 of Murray County being addressed as 110 Smokey Ford Road, owned by Steve and Susy Talley. Dick Barnes said the request was in order for presenting and he recommends approval. Nancy Young said all notices have been sent to adjacent property owners. Mr. Talley was present for the meeting. Public portion of the meeting open for comments from the audience. Mrs. Carrol, Mr. Talley's neighbor asked if the re-zone would change the zone of her property, Mr. Anglea told her no it would not. No one else either for or against the request. Public portion of the meeting closed for board discussion. David McDaniel made a motion to approve the request 2nd by Darrell Smith, all in favor, none opposed, motion carried.

Item 4. Re-Classification of property from AG to RR, located in land lot 212 district 9 of Murray County being 5 acres, owned by Elbert and Frieda Travis addressed on Bishop Road. Dick Barnes said the request was in order for hearing and he recommends approval. Nancy Young said all notices had been sent to adjacent property owners. Public portion of hearing open for audience comments. Ernest Majors was concerned that the road would have to be widened and his house was already too close to the road as were some other houses. Mr. Barnes said the road is a county road and if in the future it needed to be widened the county would approach each owner to discuss the needed property. No one present either for or against the request. Public portion of the hearing closed for board discussion. Darrell Smith made a motion to approve the request, 2nd by Edward Dunn. Steve Anglea made a comment that he is not in favor of having more mobile home lots in the county, no other comments, all in favor, none opposed, motion carried.

Election for chair-person discussed. Edward Dunn made a motion to nominate Steve Anglea for chairman. No other nominations. Darrell Smith 2nd the motion, all in favor of Steve Anglea being chairman, none opposed, motion carried.

Edward Dunn made a motion to adjourn 2nd by David McDaniel, all in favor, none opposed, motion carried.

- B. RL Jennings and Company, PC presented the Murray County Financial Report for Fiscal Year Ended December 31, 2008.**

Commissioner Ridley asked the audience if they had any questions for Mr. Lee Jennings. Steve Noland asked Mr. Jennings a question on taxes collected, Mr. Jennings told Mr. Noland that taxes collected goes 60 days in the next year and accrued revenue received back in.
